**POOL EVENT AGREEMENT – After-Hours / Private**

**The Cumberland Hill Pool is available for evening private events  
to CHSPA **Charter Partners** and **Pool Members** only.**

**EVENT INFO:**

- This will be a **2 hour** private event after the pool closes for a maximum of 100 guests.
- Fees:
  - \$350 for 1-60 guests
  - \$400 for 61-100 guests
- Available Hours:
  - Sunday - Thursday: 8:00pm – 10:00pm
  - Friday & Saturday: 9:00pm – 11:00pm

**DEPOSITS:**

You must submit **2** checks with this full agreement form to confirm your reservation:

- 1) \$50 reservation deposit. This deposit will fully confirm your reservation, and it will be applied to the total rental fee; the balance of which is due **3** days before your event. It is refundable if cancellation is given 72 hours in advance.
- 2) \$100 cleaning/damage deposit. This check will not be cashed immediately, and it will be shredded unless an inspection by a representative of CHSPA deems that extra or excessive cleaning was required by our staff.

**Renter agrees to the following:**

1. Renter will provide at least one adult (defined at 25 years of age or older) for every 10 guests of the party present on the property below the age of 21; and at least one of the adult members must be present with the group at all times.
2. The group will abide by any and all of the facility operating rules and instructions of the lifeguards, management company or representatives of CHSPA.
3. Lifeguards reserve the right to ask any unruly participants to leave the premises.
4. Pool deck and Snack Bar areas will be cleaned up and all trash thrown away at the end of the event.
